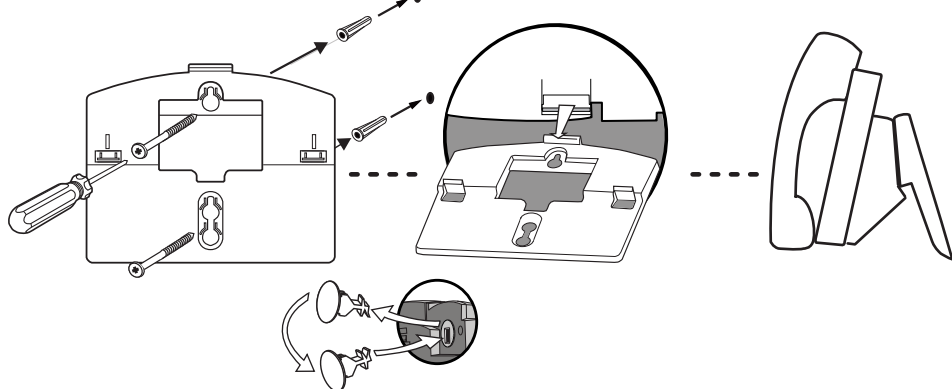

Desktop Installation



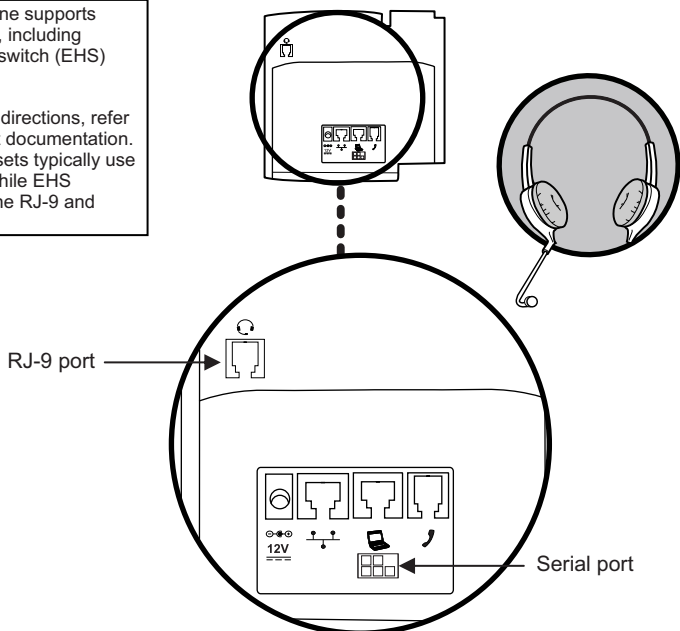
Wallmount Installation
